The members of the Task Force work as Undercover Officers and locate prostitution racket location i.e brothel, spa, five star hotels, flats, kothis, etc and further intervene and conduct raid and rescue victims.

The Project is an Undercover Operation and more than 100s of prostitute and brokers work for (R.O.T.F) to trap traffickers therefore all the details and information is only shared with Expert Licensed Member after the completion of training to maintain high level privacy and secrecy. The Task Force will be assisting many Government Enforcement Agencies like AHTU, Interstate police team, DCPCR and various Stakeholders.





## **ABOUT THE TRAINING COURSE**



Trafficking of women and children is one of the grave organized crime, extending beyond boundaries and jurisdictions. Combating and preventing human trafficking requires holistic approach by all stakeholders and integrated actions on prosecution, prevention and protection. successful conviction of offenders, redressal of grievances of victims and consequent prevention of crimes of human trafficking is possible when the responders i.e. the police agencies perform their task diligently. The Task includes collection of intelligence of crimes, registering crimes in the police station, prompt action in investigation and prosecution and also ensuring all legal and administrative follow-up measures. Police plays a vital role in prevention of trafficking of women and children for commercial sexual exploitation in cooperation with the other stakeholders.n India, sections of Immoral Traffic Prevention Act (ITPA 1956) explain the various activities involved in trafficking.

Under Section 5, trafficking includes procuring, taking and even inducing a person for the sake of prostitution. Even attempt to procure and attempt to take or cause a person to carry on prostitution is an offence. This Manual provides this capability. Training on AHT, no doubt is a synthesis of the 'knowledge' related to the legal and procedural aspects dealing with AHT; with the 'skills', of the officers who investigate cases of AHT, and 'attitude', of trafficked viewing the person of exploitation that gets victim/survivor translated in the manner of dealing with the victim/survivor. This Manual attempts to bring about this three-pronged change through its contents and via its application. The manual highlights that police, as the upholder of human rights, have to claim their rightful opportunity vis-à-vis securing the trust and confidence of the victim/survivor. This casts a duty on police to prevent and combat human trafficking (HT). This Manual empowers the police agencies in this direction.

# **OBJECTIVES OF PROGRAM**

- 1. To build clarity on the definition and elements of trafficking.
- 2. To understand and identify the processes involved in trafficking.
- 3. To understand Undercover operation to trap traffickers through the help of prostitute and ex-brokers.
- 4.To understand, and to be able to discern between the different actors involved in the activity of trafficking Who is a victim/survivor and who is an offender/trafficker?
- 5. To help participants understand and distinguish between HT vs. prostitution HT vs. migration HT vs. smuggling
- 6. To identify other forms of trafficking apart from that for commercial sexual exploitation (CSE).
- 7. To understand issues of vulnerability and the magnitude of the problem of human trafficking.
- 8. To understand the varied dimensions of trafficking and to understand its ramifications as an 'organized crime'.
- 9. To be able to conduct raid following the legal protocol.
- 10. To be able to rescue victims and successfully complete the rehabilitation process.



# **LEARNING OUTCOMES**

- 1. Operational insights in countering crimes through task-oriented joint-operations.
- 2. Field Visit to (Police Station, Forensic Labs, Prison, Court, Red Light Areas, CWC, juvenile homes, etc) to gain on field experience.
- 3. Multidisciplinary understanding of the actors and stakeholders involved in joint-operations.
- 4. Police and R.O.T.F Preparedness in how to respond to human trafficking crimes across India.
- 5. Basic understanding of Legal Instruments to prevent and control crimes against women and children.
- 6. Technology-based effective solutions in tracking and tracing Criminal Networks and busting crime syndicates.
- 7. Intervene in crimes and apprehend criminals accused of kidnapping, extortion, human trafficking, abduction, sexual exploitation, rape, bonded labor, prostituion, etc.
- 8. Conduct chain of raid and rescue women and children from forced sexual slavery.
- 9. Undercover operation to trap traffickers and rescue minors and end cycle of human trafficking.



# **METHODOLOGY**

Three months of the online+offline session will be through Live calsses and on-field training. There are separate timings of the session for each week. Each session will be of one hour (45 mins presentation/talk followed by 15 min question-answer session). Participants enrolled for offline mode will receive training in Delhi training center. While participants opting for online mode will receive the link of the live session in advance through their registered email address, for uninterrupted session attendees are requested to download the Zoom app in their respective mode of connection (Laptop, Mobile Phone etc.) Live demo raid and Field visit to Police station, Forensic labs, red light area, prison and court will be conducted during the last 2 week of training in batches. Participants opting for online mode have to visit the training center prior to on-field training and live raid.

Any training is attempted with an objective to bring about some change. Change involves both learning and unlearning. While it is, at times, easier to 'accept' new information and practices, it has been found that practical tranning and on-field experiences lead to greater understanding of any course.
